In your new role, we encourage you to take full advantage of the Office of Behavioral and Social Sciences Research (OBSSR) and its new Director, Dr. Jane Simoni. OBSSR serves an efficient coordinating role, improving the synergy of basic and applied behavioral and social sciences research with biomedical research; enhancing the research infrastructure, methods, and measures needed to support a more cumulative and integrated approach; and facilitating the adoption of research findings into practice. Capitalizing on new OBSSR leadership by engaging with Dr. Simoni and involving her and her team in the NIH Office of the Director and trans-NIH activities would be a meaningful first step toward enhancing its integrative capacity.

We are grateful for your willingness to serve in this role and for your established commitment to advancing health for our nation. We will make every effort to support your success in this role and embrace the opportunity to leverage the behavioral and social sciences to improve public health and wellbeing.
