Debrief on November Board of Directors meeting

- Approval of new gender option on membership applications
 - Male, female, transgender, other and prefer not to answer, plus Mx. prefix were approved and will all be updated on membership applications.
- Fellow engagement during 40th Anniversary Celebration at Annual Meeting
 - Videos, a reception, cake, and breakout sessions are planned. Program Committee is inviting videos from Wisdom Council and, per Membership Council suggestion, fellows will also be asked to provide videos and photos. Fellows said in past interviews with fellows that they want to be personally asked to do projects like this. Membership Council members will send personal follow ups to the fellows they talked to previously.
 - **ACTION:** Dr. Mama will send a list of fellows around so council members can sign up to contact specific fellows.
- Format of New Member Meet and Greet
 - Moved to Wednesday, March 6 at 6:30 p.m. at the council's request (allows the opportunity to attend a SIG's breakfast on Thursday), and following the anniversary celebration – celebration attendees will walk past the meet and greet to get to the poster hall so foot traffic should be good. Council members decided no other format changes would be advised this year.
- Term limits for council members
 - Membership Council has some that have served for nearly 10 years; there are technically three-year terms, though renewals are allowed.  - The DHC suggested this, but it could be overseen by the Membership Council as it already keeps an eye on membership diversity.
