#### 1. Practice gap review

Dr. Shelton let a review of the practice gap drafts. The committee read through each of the practice gaps (listed below) and made minor grammatical updates, staff to update after the call. #### 3. Review of abstract submission questions

The committee took a close look at the call for abstracts and wording of the abstract instructions to determine if any revisions needed to be made. The group identified the need to specify that results are a recommended section. The committee also elected to make the funding agencies and professional organizations questions located in the Additional Information section of abstract submission required and Ms. Dean will follow-up after the call with updated wording.

## 4. Next steps for engaging local sponsors discussion

SBM staff and leadership will be meeting with the Local Arrangements Committee on Wednesday, June 28, and are looking for input to provide them with relating to the next steps in contacting and engaging local sponsors. Ms. Dean recommended using the prospectus' that is currently being developed and tailoring the cover page to be specific to the potential local sponsor.

During the large program committee call on Tuesday, June 13, Charles Jonassaint inquired about the Behavioral Informatics and Technology SIG Datablitz could be submitted as a session other than breakfast roundtable to allow for additional presentation time.

After a brief discussion, Dr. Shelton and staff recommend submitting the proposal as a midday meeting (which are held on Thursday and/or Friday from 10:45am-11:45am). This will allow for 15 additional minutes for presentations. Staff will follow-up with Dr. Jonassaint and copy Dr. Shelton.

## 6. Op-ed request follow-up

Dr. Shelton shared that she had received a request from Jamie Bodenlos, PhD, from the SBM ETCD council inquiring about the possibility of offering an op-ed session at the Annual Meeting. The request was discussed by the ETCD and it has been determined that two sessions will be developed relating to op-eds. 1. A panel discussion led by senior SBM members discussing their experiences writing and teaching op-eds and 2. A pre-conference course targeted at student members on how to incorporate op-eds into curriculum.

Ms. Dean mentioned that the Health Policy Committee is also in the beginning stages of developing a session on op-eds highlighting success stories.
