 - Does support SBMs long term vision
 - We haven't used them recently, but they could be of use to use moving forward as we launch our ambassadors program
 - \$1500 fee- includes training resources for our membership
 - Could have run its course as we go in a different policy direction
 - Wasn't clear what level this would be at
 - Would it be more appropriate for the Health Policy group to maintain this partnership- doesn't reach the level of SPLC
 - Using them mainly as a training resource, rather than a partnership
 - **ACTION:** Amy to discuss with Joanna to have the Health Policy group take over the relationship

- SBM members can apply for their leadership team
- Request a liaison for ISBM, if they are to a core strategic partnership
 - As a standing council member, or at least quarterly
- At least a level 3, borderline level 4 or higher
- An asset to SBM to partner with them as an international connection
- This liaison could be someone who joins the council
- **ACTION:** Amy to reach out to their leadership team to identify a liaison
 - Michael Diefenbach may already have a relationship
- Finalize external partner review process using our rubrics and partnership levels.
 - [SPLC Guidance Doc](#)
 - Individuals who manage a 3 or higher partnership that they should be joining SPLC at least quarterly
 - The council will primarily do more big picture thinking while having the liaisons be periodic members who join us on a quarterly basis
 - SPLC member would be the contact person for multiple liaison partnerships
 - 1 person= 1 liaison would cause a capacity problem. SPLC can't manage all of those members for each meeting.
 - Liaison for partnerships with a level 3 or higher could have a permanent spot of the council
 - **ACTION:** Come to a conclusion during the next meeting
 - Discuss council role
 - **Kimberly to add to the next agenda**

- COVID planning moving forward
 - Review MOUs for adjustments
 - Partner outreach to assess how we are able to move forward (if we are able to do so at this time)
